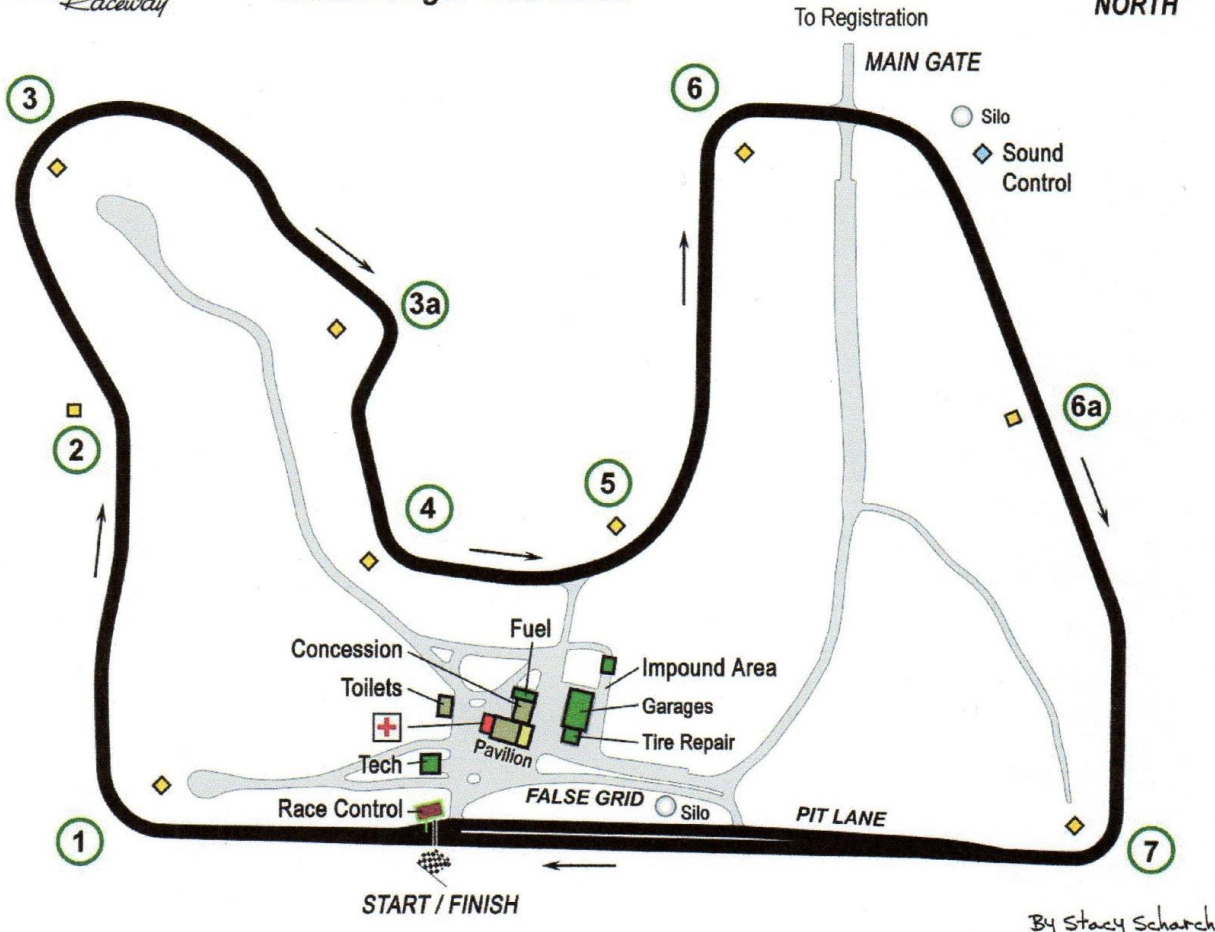

## **Minor Participation Procedures**

Midwestern Council (MC) allows 14-17 year olds ("Minors") to compete in Wheel-to-Wheel (W2W) and High Speed Autocross (HSAX) events.

**Note – 14/15 year olds are only eligible to participate if they can provide sufficient and verifiable experience prior to the school date. Contact the Chief of School for additional information.**

All Minor participants must comply with the following procedures:

All Minor participants in W2W and/or HSAX **MUST** successfully complete a full day MC Driver School for the type of competition in which they wish to participate. Driver school may be waived by the Competition Director with an acceptable and verifiable current racing resume. Upon successfully completing a Driver School, or waiver by Competition Director, a Minor Participation License (MPL) or HSAX Minor Participation Certificate will be issued.

A "MINOR RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT" (Minor Release) form must be signed by one parent/legal guardian and in the possession of the MC Competition Director prior to a Minor being allowed to participate in a Midwestern Council event. To receive a blank Minor Release, the applicant must join a MCSCC club and contact the Steward of the club he/she joins, or the Chief of School. Notarized releases are valid until December 31st of the year in which they are signed and must be submitted each year until the Minor attains 18 years of age. The Competition Director will supply copies of this form to the MC President and Competition Licensing Director. A copy of the form will be provided to each event Chief Steward and Registrar for signature comparison with the form that will be completed by the Minor and attending parent/guardian at the events entered.

All Minors applying for a W2W Novice License must submit a Midwestern Council medical form; no other medical forms will be accepted.

At registration of each event entered, a Minor Release for that event shall be filled out and signed by the minor and attending parent/guardian. (Only one parent/guardian need attend events.) The Registrar will compare the signatures to those on the copied form. If believed to be the same, the Registrar is to sign and date the event release as a witness.

**If at any time the attending parent/guardian intends to leave the track property, that parent/guardian is to inform the Chief Steward of intent to leave. Upon returning, the parent/guardian is to report to the Chief Steward. While the parent/guardian is away, the minor will not be allowed in restricted areas.**

Minor W2W participants shall only be eligible for a "Minor Participation License" (MPL). While holding an MPL the participant shall conform to all regulations for both Novice and Probation licenses as detailed in the GCR. In addition, the driver must personally present the MPL to the event Chief Steward accompanied by the attending parent/guardian. Renewal of an MPL is similar to that of a Novice license. HSAX Minor Participation Certificates are to be sent to the Competition License Director for second year renewal as would the MPL.

Upon reaching 18, Minor Participation License holders are eligible to upgrade to the license level appropriate for the number of races completed while on the MPL.

  - \_\_\_\_\_ **Wheel Bearings:** No play is acceptable.
  - \_\_\_\_\_ **Driver Apparel:** Natural fibers, long pants, long sleeves and closed toe shoes. Nomex suits required for comp group drivers.
  - \_\_\_\_\_ **Helmet:** Snell K, M or SA, 2010 or Newer. DOT or 2005 & older are not valid.
  - \_\_\_\_\_ **Wheels:** No cracks, must be straight.

## **Supplemental Regulations**

### **1. General Event Regulations**

- 1.1. This event is sanctioned by the Midwestern Council of Sports Car Clubs, and insurance conforms to MCSCC requirements. This event will be held under the MCSCC General Competition Regulations, Track Regulations and all Supplemental Regulations.
- 1.2. Drivers are responsible for notifying crew and guests of the hours Registration is open. Entry may not be available beyond posted hours.
- 1.3. Minor guests must be under adult supervision at all times.
- 1.4. A slow and safe speed shall be maintained in the paddock at all times. Riding on the exterior of vehicles is prohibited.
- 1.5. No intoxicants may be consumed by drivers, crew or guests before the end of the last race or other on-track activity. There may be General Admission spectators not registered with event sponsors which are not subject to this rule.
- 1.6. No illegal drugs or controlled substance shall be tolerated on the track premises at any time.
- 1.7. Any and all protests, questions or complaints against any competitor's car or driving or against any race specialty should be made to the Event Chief Steward or his/her designated assistant as stipulated in the GCR. In no case should complaints be directed to any race worker in any specialty.
- 1.8. All race support vehicles (ATVs, golf carts, etc.) must bear a legible placard with the entrant's car number and class designation.

### **2. Autocross Supplemental Regulations**

#### **2.1. Autocross Entry and Registration**

- 2.1.1. Midwestern Council High Speed Autocross events are open to anyone with proof of a valid state driver's license.
  - 2.1.1.1. 16 thru 17 year olds may participate if accompanied by a parent/guardian & they turn in to the event Chief Steward a Midwestern Council HSAX Minor Participation Certificate.
  - 2.1.1.2. The minor accompanied by the attending parent/guardian is responsible for picking up the Midwestern Council HSAX Minor Participation Certificate from the event Chief Steward before leaving the facility.
  - 2.1.1.3. The parent/guardian must report to the Event Chief Steward if he intends to leave the track property and upon his return. The minor participant will NOT be allowed on the race track while the parent/guardian is not present.
- 2.1.2. Any car on track during practice sessions or timed runs is to be driven **ONLY** by the individual registered to that car, number and class. The **ONLY** exception is a certified instructor teaching a Novice during practice sessions.
- 2.1.3. Only drivers who are Midwestern Council members presenting a Midwestern Council HSAX ID number will be awarded championship points.
- 2.1.4. Autocross officials reserve the right to alter the schedule for good and sufficient reason, and to reject any entry at their discretion. Officials reserve the right to reassign car numbers where required.
- 2.1.5. Drivers competing in a MCSCC High Speed Autocross for the first time must place an "N" on their windshield and attend the Novice meeting (see schedule) and the special Novice practice following.

#### **2.2. Autocross Tech & Safety Regulations**

- 2.2.1. Cars must be generally suited for track use and must pass *High Speed Autocross* Technical Inspection. A neat and clean appearance is required.
- 2.2.2. Car numbers must be at least 6" high and of 1" stroke, and white in color unless the background is white in which case the numbers must be black. Shoe polish is not allowed. Numbers shall be displayed on both sides of the car and at the top corner of the windshield on the side facing T&S without interfering with the driver's ability to see to the front. Car class and practice group number shall be displayed on the windshield also, in a manner not to conflict with the car number. Numbers are the driver's responsibility, and will not be supplied by Tech nor will tech supply materials to create numbers.
- 2.2.3. Seat belts must be in place and used at all times. OEM seat/shoulder belts are acceptable in all classes except those cars requiring a roll bar. Cars requiring a roll bar must have a 4-point (minimum) harness ("Euro Harness" acceptable). Competition belts & harnesses are required in all open cars in any class.
- 2.2.4. Open cars are required to have roll bars meeting Appendix Z or ZZ of MCSCC General Competition Regulations. Targa and T-Top cars are considered open cars unless tops are installed and locked in place. Roll bars are strongly recommended for all cars.
- 2.2.5. All drivers must wear a Snell Foundation approved helmet. Helmets meeting at least Snell K2010, M2010 or SA2010 rating are required. SA rated helmets are very highly recommended. Loaner helmets are not available.
- 2.2.6. Drivers must wear full coverage shoes, long pants and long sleeved shirts, with sleeves rolled down, when on track. Approved driving suits are highly recommended.
- 2.2.7. Sound control - All cars are required to comply with the decibel limit established by the track (see track regulations). If a car is recorded in excess of the limit during an on track session, the first two times the driver will be notified of the

infraction as the car enters the paddock and instructed to make repairs. If the car is subsequently recorded in excess of the limit it will be disqualified from further participation at that event.

### **2.3. Autocross General**

- 2.3.1. Only approved driving instructors may ride in cars on the track. No other passengers will be allowed during practice or timed runs.
- 2.3.2. Passing is allowed only in designated areas which will be defined at the Mandatory Drivers Meeting.
- 2.3.3. If Blue Flagged, on the racing line and allow faster cars to pass.
- 2.3.4. Anyone failing to exit at the designated exit point, to be identified at the Mandatory Drivers Meeting may lose his/her next practice session or timed run.
- 2.3.5. Left and right front door windows must be open whenever the car is on track.
- 2.3.6. Where available, participants in a Midwestern Council HSAX event are prohibited from participating on facilities adjacent to that upon which the MCSCC event is being held. Upon being observed doing so, said competitor will be prohibited from participating in a timed run without first being held by grid for a minimum of five (5) minutes.
- 2.3.7. Timed runs must be completed whenever possible. (Not doing so creates problems for Timing & Scoring.)
- 2.3.8. If a re-run is approved by the Stewards, the car will be held for a five (5) minute period before the re-run will be allowed.

### **2.4 Special Event Scoring**

- 2.4.1 This HSAX to take place on Monday, July 3, 2017 is a DOUBLE POINTS event. Scoring will be calculated in accordance with HSAX GCR section 9.2 . Resulting points at the end of competition for the day will then be doubled and applied towards the season championship for all Midwestern Council members with a HSAX ID number.

### **3. Track Regulations**

- 3.1. No race car engines shall be run before 8:00am or after 6:00pm on any weekend day or not before 9:00am or after 4:30pm on weekdays (Monday through Friday). All racing or on track activities shall be conducted at a decibel level not in excess of 103 decibels as measured Fifty (50) feet from the track.
- 3.2. A pass indicating that you have registered for the event must be presented to the guard to allow your entry onto the property of Blackhawk Farms Raceway.
- 3.3. All minors must be under direct parental or acting guardian supervision at all times.
- 3.4. Drivers are responsible for the conduct of their crew and guests.
- 3.5. All pet animals MUST be leashed or confined.
- 3.6. No two or three wheeled vehicles are allowed except for race officials' use or as race support vehicles. Only licensed drivers 16 and above may operate race support vehicles or golf carts.
- 3.7. The concession stand will be available for events. Gas, oil, water and air are available.
- 3.8. All trash MUST be placed in receptacles provided. Environmentally hazardous waste MUST be disposed of in appropriate receptacles. All tires MUST be removed or the organization will be charged for their disposal.
- 3.9. Electric power is available. Tags for the outlets will be issued and payment arrangements can be made with security or in Pit Stop. Cost for electric is \$25 for weekend or \$10 for single weekday event. Anyone plugging in prior to purchasing an electrical tag will be subject to paying \$30 for weekend or \$15 for a weekday.
- 3.10. All drivers, members, officials and spectators must comply with the Pit Vehicle Policy of BFR; including the purchase and display for a Pit Vehicle Pass for each unit on the premises. Pit Vehicle Passes are \$25 for the season or \$10 for single event.
- 3.11. All vendors, including photographers, are required to pay a vendor fee of \$150 for an event or \$75 per weekday.

### **4. Cancellation/Refund Policy**

- 4.1. Refunds will be given at the discretion of the event registrar. Absolutely no refunds will be given for any participant that has seen track time. Changes in weather will not constitute reasoning for refunds. All refunds will be subject to processing fee charge of \$20 or as deemed necessary by event registrar. Refund requests must be made to event registrar listed on the entry form.
