FoS is arranging the track rental, insurance, and services, provided for you via INWR PCA. INWR PCA is also assisting with registering drivers for this session.

This is a track event for open lapping, not competition. It is intended for new or experienced track drivers desiring to drive their Porsches or other manufacturer cars on a track in a safe, controlled manner.

This event is NOT open to cars participating in the SOVERN Test 'n Tune on Friday afternoon or the SOVERN races on Saturday and Sunday.

Run Groups

Cars will be divided into run groups based on the experience and capabilities of the drivers. The performance capabilities of the cars is a secondary factor for run group assignment.

For those with no or very limited track experience, the driver will be placed in a group that will use a leadfollow method with experience drivers conducting controlled exercises for braking, cornering, the correct line, and passing.

- 3. No passengers.
- 4. Though not a PCA event, PCA driver restraint requirements will be enforced
 - Factory 3-point seat belt in cars without rollover protection.
 - If a rollbar is installed the car/driver must have:
 - 5-point or 6-point harness
 - o Competition seat with passages for the shoulder, lap, and antisubmarine belts of the harness
 - o Driver wear a head and neck restraint (HANS) within current approved dates
 - Passengers equally equipped with harness, seat, and HANS. (No passengers this event so not applicable.)
- 5. SA2015, SA2020, M2015, or M2020 approved helmet. DOT or other "street" approved helmets are not acceptable.
