Every inspection point listed below must be initialed or marked "n/a" by the person conducting the inspection.

DRIVER SAFETY

- Helmet (Snell K/M/SA 2015 or newer, SFI, FIA)
- Shoes must be closed-toe and in good condition
- Seatbelts/harnesses must be in good condition
- A proper roll bar when it is required
- Roll bar padding
- Seats bolted securely
- Interior and trunk clear of loose items

BRAKES

- Brake pads are less than half-worn
- Fluid is clear. Reservoir is full. DOT 4 recommended
- Pedal is firm
- All brake lights are working
- Master cylinder/calipers are not leaking
- Rotors are not cracked or discolored

TIRES AND WHEELS

- Adequate tire tread, speed rating, good condition
- All lug nuts present and torqued
- Hubcaps removed
- Wheels - no cracks or structural damage

SUSPENSION AND STEERING

- Wheel bearings - no excessive play
- Suspension in overall good condition
- No excessive steering play
- Shock absorbers - no leakage

ENGINE AND DRIVE TRAIN

- Check all fluid levels, belts, and hoses
- Tighten all underhood caps
- No fluid leaks (oil, fuel, coolant)
- Battery secured (no bungees)
- Battery positive terminals covered
- Overflow containers present and functional
- Exhaust system functional (may have to satisfy sound restrictions)
- Throttle has quick, positive return
- Fuel cap secured

OTHER

- Windshield and rear window are not cracked
- Windshield wipers function properly
- Inside & outside rear view mirrors present
- Car numbers on both sides (vinyl or tape)
