

## 2023 EDKRA RV/Pit Stall Policy:

- Stalls are reserved for karting use from April 1 to September 30<sup>th</sup>.
- Pit stalls are for race trailers & equipment *only* – *RV's only in designated areas*.
- RV units or toy haulers are not permitted in reservable pit stalls 1-73 (not applicable to out-of-town racers). Paid full-service RV stalls & Power Only RV stalls include overwinter fees for the RV only. Any other equipment/trailers/structures are subject to overwinter fees of \$200/15' unit.
- One reserved pit stall is included with an individual or family membership for **active** racing EDKRA club members *only*.
  - Members must be in good standing with EDKRA.
  - **Active** racing members are defined as members actively participating in multiple & regular race events throughout the racing year – more than 70% of scheduled races.
  - **Non-active** racing members are eligible to use available *unreserved* pit stalls on a first come, first serve basis. Available unreserved stalls will be labelled. Once practice or any occasional race weekend is complete, all racing equipment/trailers must be moved to the unreserved overflow area or away from the track.
  - Multi-racer families can request a larger pit stall or multiple pit stalls to facilitate their team & additional karts.
- All Pit & RV stalls must be maintained by the occupant – keeping the area tidy, free of debris & weeds. Financial penalties or removal of privileges may be invoked on violators.
  - The occupant can use club supplied pesticides &/or applicator to keep their areas free of weeds – an instruction sheet will be posted with the chemical & applicator.
- During large race events, EDKRA club members may be asked for the use of their pit stall to accommodate large race teams and dealers.
- All pit stall requests must be approved by the executive.
- Returning members have first right of refusal until April 10<sup>th</sup>. Membership and previous stall holder reservations opens March 1<sup>st</sup> and new Pit/RV stall requests open April 15<sup>th</sup>. Any available reservable stalls will be posted on our website on April 15<sup>th</sup>.
- Pit/RV stalls are available to be reserved via MotorSportReg.
- After October 1<sup>st</sup>, you will need to purchase overwinter fees to store your unit at \$200 per unit/trailer/building/structure & if your structure is more than 8' wide, the fee is \$200 per 15' front lineage (e.g. 30' wide building would pay overwinter fees for 2 units, 38' wide building would pay overwinter fees for 3 units, etc).

## Semi-permanent Structures:

- **All** semi-permanent structures **require** pre-approval and a signed agreement with the club executive.
- **Prior** to commencement, a proposal **must** be submitted for approval to the executive to ensure compliance & alignment with club goals & policies.
- Due to the historical damage & losses encountered by tents, no further approvals will be given.
- Any tent like structures must be taken down/lowered at the end of the day.
- The single existing 20'x30' coverall tent is grandfathered on stall 91.
