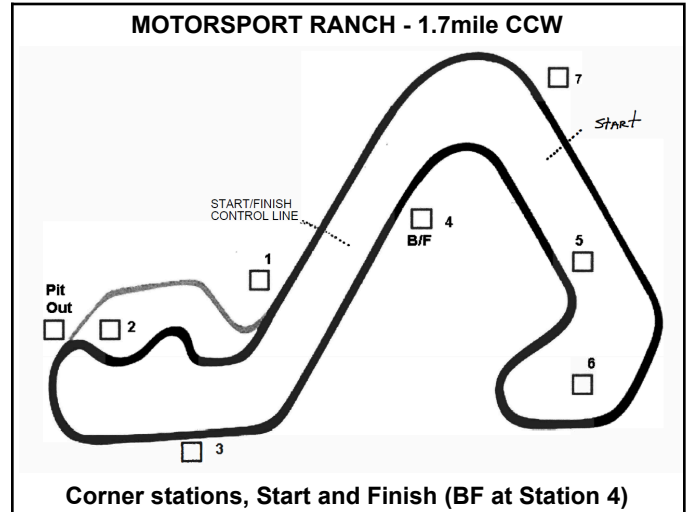

## SUPPLEMENTAL REGULATIONS



This event is governed by the 2026 General Competition Rules (GCR) and Category Specifications, as amended for 2026 per "Fastrack", except as modified by these Supplemental Regulations

### I. REGISTRATION and FEES



- A. ENTRY FEES:** Entry Fee for the two-day weekend is \$625. Second entry same driver \$470. Each SRF3. SRF, FE2, FE, SM and SMX entry will be charged an additional \$30 compliance fee per entry for the weekend. The Runoffs Appearance Fund fee of \$20 will be charged to each Runoffs Eligible Entry .
- B. PAYMENTS & REFUNDS:** Online registration is at the following link <http://msreg.com/26TXSCCAFling>  
An entry is not considered complete until the proper fee is received. Online registration will close Tuesday March 31, 2026 at 11:59 PM. Credit cards will not be processed before April 1, 2026. **All entries received prior to March 24, 2026 at 11:59 PM will receive a \$50 early bird discount** as a token of our appreciation for planning ahead.  
A refund will be made if the entry does not go on track during any practice, qualifying, or race session. Withdrawal notifications are accepted by email, phone, or in person to the Chief Registrar or via MotorsportReg.com and would be greatly appreciated in advance of the event, but no later than noon on Saturday March 4, 2026.
- C. WAIVERS:** During check-in, all event participants must sign the MSR Waivers form and those without a SCCA Annual waiver must also sign the SCCA waivers form. Wristbands will then be issued and must be displayed throughout the event.
- D. PASSES:** Each entry receives five (5) passes total, including the driver and entrant. Workers, guests, & crew must sign for their own passes and must arrive while registration is open. Workers and crew members must be SCCA members. Weekend memberships are available for purchase (\$25) if needed. SCCA members (non-participants) must present a valid membership card for admission.
- E. PADDOCK AND GARAGE RESERVATION:** All parking is first come first served. Gates open for load-in at 2:30pm on April 2, 2026. Reservation for Carports may be determined at a later date.
- F. PREFERRED NUMBERS:** Every effort will be made to honor Conference Preferred Numbers until 14 days prior to the event. However, due to the make-up of the run groups, this may not be possible in all situations. If two drivers holding the same Preferred Number request that number for the same run group, the number will be assigned to the driver with the earliest entry.
- G. PADDOCK/PARKING INFORMATION:** Gates will open at 2:30 on April 2, 2026 for parking. Please be respectful of the space you take up. No parking between/around member garage buildings.

### II. DRIVER INFORMATION

- A. DRIVER ELIGIBILITY:** Drivers must be a current member of the SCCA and hold a SCCA Full Competition license to participate in this event. If you do not have the proper credentials it is your responsibility to contact the Registrar prior to the event. If the Chief Steward allows the substitution of a car or driver, per GCR 5.12.3.A.6, any qualifying times earned for the original car/driver up to that point will be removed.
- B. CAR ELIGIBILITY:** Competition is open to all cars conforming to the 2026 GCR, as amended. Regional classes not delineated in the Current GCR are listed on the Southwest Division Website. <https://sowdivscca.com/road-racing/regional-class-rules/> **ALL CARS COMPETING UNDER A REGIONAL RULESET MUST CONFORM TO CURRENT Section 9 SCCA GCR SAFETY STANDARDS AND MUST HAVE A LOGBOOK ISSUED BY SCCA.**

- C. **TIMING & SCORING:** All cars are required to use fully operational MyLaps (formerly AMB) transponders, and the driver is responsible for providing the correct information to Timing & Scoring. Make sure your transponder is on and functioning for ALL SESSIONS. Information gathered from personal timing and data collection systems is unofficial and will not be used by race officials. Cars without working transponders may not receive times.
  - D. **COURSE:** Motorsport Ranch, 1.7 mile course, Counter-Clockwise.
  - E. **STEWARD OF THE COURSE (SOC/Black Flag Steward):** Located at Pit Lane Exit to Paddock.
  - F. **PASSING UNDER YELLOW FLAG:** All reported instances of PUY will be investigated by the stewards and verified passes under yellow flag conditions will be assessed penalties in accordance with the 2026 Road Race Standard Penalty Guidelines.
  - G. **BLACK FLAG:** Mechanical and Driver Infraction Black Flags will be displayed at both the Starters Stand and at Turn 4. Upon receiving a Black Flag, Driver is expected to exit the race track and report to the SOC in the hot pit lane. Drivers failing to respond promptly to a Black Flag may be subject to Chief Steward penalties.
  - H. **CAMERAS:** Drivers are reminded that functioning cameras are required during ALL track sessions, including during the Test Day and Practice sessions. Failure to provide video if/when requested by the stewards will incur penalties in accordance with the GCR and the 2026 Road Race Standard Penalty Guidelines.
  - I. **SOUND CONTROL:** Sound Limit 103dB, Sound Control Readings will be posted in Tech. Sound Meter Location to be determined at the event and will be posted in Tech.
  - J. **HARDSHIP LAPS:** Competitors who have mechanical problems and need to test their car at speed are encouraged to request a hardship lap, which may be allowed at the discretion of the Chief Steward. A hardship lap may not be taken immediately prior to a car's scheduled qualifying or race session.
  - K. **AWARDS:** SCCA US Majors Tour Points will be awarded in accordance with the GCR and these Supplemental Regulations. Trophies for all races will be awarded in accordance with the GCR. Southwest Division Road Racing Championship points will be awarded per 2026 SWRRC Rules and prizes awarded at the end of year.
- III. CAR SAFETY and TECH INSPECTIONS**
- A. **DECALS:** Competition vehicles must display the official SCCA Road Racing decal per GCR Section 9.3.29.C (Figure 4). Stickers will be provided free of charge and may be obtained at registration and/or tech. (The official SCCA Summit Racing Equipment Road Racing decal does not serve as the Summit Racing Equipment contingency program decal.)
  - B. **TECH:** No smoking or engines running in the Tech area. All drivers without a current year helmet sticker must present all driver gear as required by the GCR and vehicle logbook to Tech. If your car requires an annual inspection you must also bring the car to Tech.
  - C. **SCALES:** Availability of scales and times will be posted at Tech. Scales may be available for other participants during race impound, but priority will be given to impounded cars. Scales may be made available at other times at the discretion of the Chief of Tech. Teams are requested to provide crew assistance for weighing their cars.
- IV. QUALIFYING/RACE**
- A. **GRID:**
    - Practice:** Starting positions for the first sanctioned, official on-track session will be set based on order of arrival at GRID.
    - Qualifying:** Grid positions for Qualifying 1 will be determined using the fastest lap time in the official practice session. Grid positions for Qualifying 2 will be determined using the fastest lap in either Q1 or Race1
    - Saturday Race:** Grid position will be determined using the fastest lap time in the Saturday Qualifying session.
    - Sunday Race:** Grid positions will be determined by the fastest lap time recorded for each car during any of the preceding qualifying session(s) or the fastest lap during the Saturday race.
- V. IMPOUND**
- A. **MANDATORY DRIVERS MEETING:** Either a written Drivers' Meeting from Chief Steward may be emailed to all entrants/drivers in advance of the event, or an Impound All will be given at the end of the first Qualifying session for each group to conduct a driver's meeting. Impound will be in the Tech Area. Look for the signs for proper direction.

- B. SPLIT STARTS:** Drivers may request a split start after the Saturday qualifying session. The Chief Steward will approve a split start only if the majority of drivers in a session are in favor.
- C. IMPOUND:** The top three finishers in each class must report to impound immediately following the completion of their race, for both Saturday and Sunday races, for post-race inspection per the pre-approved tech plan. Drivers are not required to report to Impound after their qualifying sessions unless directed to do so by the SOC. **The Chief Steward or Tech Steward will be available in impound at the conclusion of each Qualifying and Race session for questions, clarifications or discussion of on-track incidents.**
- D. CONTACT:** GCR Section 6.11.1.E requires the driver and car involved in significant body contact to stop at the designated incident investigation site for review of the incident by stewards. "Significant body contact" includes but is not limited to: contact resulting in 2 or 4 wheels off course, spins, loss of position, or damage to the suspension or bodywork. Drivers shall satisfy this requirement by reporting to the SOC located on the pit lane at the track exit. Drivers who do not satisfy this requirement are subject to Chief Steward penalties, or may be referred to the Stewards of the Meeting (SOM).
- E. DISABLED CAR:** If during an on-track incident a car is unable to continue, the driver MUST remain in the car with all safety equipment in place while waiting for EV arrival. The ONLY exception is if the car is on fire.

#### VI. GENERAL

- A. RACE LENGTH:** Saturday races will be 25 minutes. Sunday races will be 27 laps or a minimum of 35 minutes. When the LAST LAP INDICATOR is given at Start/Finish, the next flag will be a checkered flag. In the case of a long delay and where the time limit has expired, the Chief Steward may convert to laps to allow a green, white, checker to complete the race.
- B. RESULTS:** Live timing will be available during the event through [Race Monitor](#), and may be available at [SCCA.com](#). Live timing information is neither official nor protestable. Results will only be available at [TX Region Road Racing](#) or by using the QR code at the end of these supplemental regulations.
- C. START TIMES:** For Qualifying, the session clock starts when cars are released from Grid. For Race sessions the clock starts when the first car crosses the Start/Finish Control Line after the scheduled pace lap.
- D. TIMING AND SCORING:** Due to MSR's unique track configuration, the Green Flag to start on-track sessions will be displayed at Turn 7 and the Checkered Flag to end sessions will be displayed at Turn 1, **however**, Timing and Scoring for all sessions begins and ends at the marked Start/Finish Control Line as shown on the track map in these Supplemental Regulations (reference GCR 6.10.1).
- E. EVENT SCHEDULE/RUN GROUPS:** The schedule or run groups may only be changed at the discretion of the Chief Steward, with concurrence by the Event Chair and approval by the SOM, depending on pre-race entry counts or as needed to accommodate situations during the event.
- F. CANCELLATION:** If part of an event is canceled for reasons of safety or forces beyond our control as provided by GCR Appendix B.1.2.B., points will be awarded based on race grids.
- G. CLOTHING:** Safe apparel must be worn in the pits at all times. Crew members on pit lane must display their event credential at all times while on pit lane.
- H. GRID:** All motorized vehicles (race cars and support vehicles) must enter the grid area from the designated traffic flow signage.
- I. PIT LANE:** Drivers are to maintain a safe speed on Pit Lane with absolutely no racing. Unless signaling a driver to tend to a car in the hot pits, all persons must remain behind the pit lane wall. Standing or sitting on the pit lane wall is prohibited at all times.
- J. TIRE VENDOR:** Sports Car Performance - Mike Sauce - Authorized Hoosier Tire Sales and Trackside Service. 817.860.1985(shop), 817.235.0018 (mobile), saucemik@aol.com
- K. FUEL PROVIDER:** Available at Track SUNOCO (formerly Texaco)

#### VII. TRACK RULES

- A.** Gates close on the track immediately after the last scheduled run session. The track is considered cold, and no person is allowed to enter without express consent from MSR.
- B.** Only MSR personnel may open and close the track gates prior to and after an event.
- C.** No alcohol consumption is allowed by anyone on the grounds in the facility while the track is in use.

- D. No one under the age of eighteen is permitted to operate a motorized vehicle unless they are registered with the event.
- E. Speed limit in the paddock is 15 mph.
- F. No parking between and around garage buildings.
- G. Do not leave used tires at our facility, take them with you or pay a disposal fee at one of the shops on site.
- H. Dispose of used oil in the waste oil container on site. Ask at the front desk for location.
- I. In the case of rain or mud, all vehicles must stay on pavement.
- J. Animals must remain on leash at all times, must be cleaned up after and not allowed in the clubhouse.
- K. No spectators beyond the posted limits on the grounds.
- L. Camping is allowed, however, the contracted sanctioned renting party is responsible for operational security on the grounds during closed hours, if they have registered drivers staying on the grounds.
- M. Be safe and have fun!

**VIII. OTHER**

- A. LOCATIONS: **Registration** will be located upstairs in the Club House. **Tech** and **Impound** will be located under the canopy on the north side of the Club House. **Race Control** will be located upstairs in the Club House.
- B. The Race Chairman, Chief Steward, Stewards of the Meeting, and other race officials will normally be located in the Club House or at Impound.
- C. Majors Trophies will be available after each race. SWRRC Trophies are awarded on an annual championship basis and will be awarded at the end of the season.

**IX. OTHER PROVISIONS**

- A. The Chief Steward and Stewards of the Meeting reserve the right to combine or split race groups and to modify the schedule and/or length of sessions as may be required.
- B. A Checkered Flag may be displayed at the Black Flag station (Turn 4) to indicate the end of a practice or qualifying session. During practice, drivers must proceed directly to the pits. During Qualifying and Races drivers may opt to run a cool down lap after being shown the checkered flag.
- C. Flag Station 7 will Start and Flag the Race from the back straight. The Checkered Flag will be thrown from Flag Station 1 at the end of the front straight before Turn 1.

**Drivers are reminded that they are responsible for the actions of their team members and/or guests as well as their own. Unsportsmanlike conduct by any party will not be tolerated and is subject to disciplinary action by the stewards, up to and including suspension and/or referral to the SCCA Board of Directors.**
