The SCCA strives to ensure that ALL participants in its events and activities enjoy a welcoming environment. A commitment to a welcoming environment and the SCCA Values is expected of all its members and attendees, including drivers, workers, crew, guests, staff, contractors and exhibitors, and other participants at SCCA activities, sessions and social events and when representing the SCCA in print or electronic media.

SUPPLEMENTAL REGULATIONS

This event is governed by the 2025 General Competition Rules (GCR) and Category Specifications, as amended for 2025 per "Fastrack", except as modified by these Supplemental Regulations

I. REGISTRATION and FEES

- A. ENTRY FEES:** Entry Fee for the two-day weekend is \$625. Second entry same driver \$445. Each SRF3, SRF, FE2, FE entry will be charged an additional \$30 and each SM and SMX an additional \$20 compliance fee per entry for the weekend. The Runoffs Appearance Fund fee (previously known as a tow fund fee) of \$20 will be charged to each Runoffs Eligible Entry. Any entries not received prior to close of Online Registration will incur a \$25 processing fee.
- B. PAYMENTS & REFUNDS:** Online registration is at the following link <http://msreg.com/25TXSCCAsunburnmajors>
An entry is not considered complete until the proper fee is received. Online registration will close Tuesday August 26, 2025 at 11:59 PM. Credit cards will not be processed before August 27, 2025. **All entries received prior to August 15, 2025 at 11:59 PM will receive a \$50 early bird discount** as a token of our appreciation for planning ahead.
A **refund** will be made only if the entry does not go on track during any practice, qualifying, or race session.. Withdrawal notifications are accepted by email, phone, or in person to the Chief Registrar or via MotorsportReg.com and would be greatly appreciated in advance of the event, but **no later than noon on Saturday August 30, 2025.**
- C. WAIVERS:** During check-in, all event participants must sign the ECR waivers form and those without a SCCA Annual waiver must also sign the SCCA waivers form. Wristbands will then be issued and must be displayed throughout the event.
- D. PASSES:** Each entry receives five (5) passes total, including the driver and entrant. Workers, guests, & crew must sign for their own passes and must arrive while registration is open. Each crew member signing in must be an SCCA member. Weekend memberships are available for purchase (\$20) if needed. SCCA members (non-participants) must present a valid membership card for admission.
- E. PADDOCK AND GARAGE RESERVATION:** All parking is first come first served. Gates open for load-in at **4:00 pm** on August 28, 2025. Garages are not available at Eagles Canyon.
- F. PREFERRED NUMBERS:** Every effort will be made to honor Conference Preferred Numbers until 14 days prior to the event. However, due to the make-up of the run groups, this may not be possible in all situations. If two drivers holding the same Preferred Number request that number for the same run group, the number will be assigned to the driver with the earliest entry.
- G. PADDOCK/PARKING INFORMATION:** Gates will open at **4:00 pm** for parking on August 28, 2025. Please be respectful of the space you take up. No parking between/around member garage buildings, and **NO PARKING ON LOWER PADDOCK SKID PAD SURFACE.**

II. DRIVER INFORMATION

- A. DRIVER ELIGIBILITY:** Drivers must be a current member of the SCCA and hold a SCCA Full Competition license to participate in this event. SCCA Pro Racing and other sanctioning body licenses are not accepted. If you do not have the proper credentials it is your responsibility to contact the Registrar prior to the event. If the Chief Steward allows the substitution of a car or driver, per GCR 5.12.3.A.6, any qualifying times earned for the original car/driver up to that point will be removed.

- B. CAR ELIGIBILITY:** Competition is open to all cars conforming to the 2025 GCR, as amended. Regional classes not delineated in the Current GCR are listed on the Southwest Division Website.
<https://sowdivscca.com/road-racing/regional-class-rules/> ALL CARS COMPETING UNDER A REGIONAL RULESET MUST CONFORM TO CURRENT Section 9 SCCA GCR SAFETY STANDARDS AND MUST HAVE A LOGBOOK ISSUED BY SCCA.
 - C. TIMING & SCORING:** All cars are required to use fully operational MyLaps (formerly AMB) transponders, and the driver is responsible for providing the correct information to Timing & Scoring. Make sure your transponder is on and functioning for ALL SESSIONS. Information gathered from personal timing and data collection systems is unofficial and will not be used by race officials. Cars without working transponders may not receive times.
 - D. COURSE:** Eagles Canyon Raceway, 2.7 mile course, Counter-Clockwise.
 - E. STEWARD OF THE COURSE (SOC/Black Flag Steward):** Located at Pit Lane Exit to Paddock
 - F. BLACK FLAG:** Mechanical and Driver Infraction Black Flags will be displayed at both the Starters Stand and at Turn 11. Upon receiving a Black Flag, Driver is expected to exit the race track and report to the SOC in the hot pit lane. Drivers failing to respond promptly to a Black Flag may be subject to Chief Steward penalties.
 - G. PACE LAP/FULL COURSE YELLOW PROCEDURES:** In addition to GCR 6.6.2., the field shall follow the Pace/Safety car as long as its emergency lights are flashing, even if it varies from the normal race course. Upon display of a full course yellow, the race leader MUST slow to typical pace car speed (approximately 40-50 mph) and gather the field behind as soon as practical. Trailing cars MUST pack up behind the leader, using caution that cars ahead may be at a much slower pace. Failure to pack up behind the leader when sufficient opportunity exists will be reviewed by the stewards and may result in a penalty.
 - H. SOUND CONTROL:** Sound Control will not be in effect for this event.
 - I. HARDSHIP LAPS:** Competitors who have mechanical problems and need to test their car at speed are encouraged to request a hardship lap, which may be allowed at the discretion of the Chief Steward. A hardship lap may not be taken immediately prior to a car's scheduled qualifying or race session.
 - J. BLEND LINE:** Please be aware of the pit out blend line leading to Turn 1. Cars exiting the hot pit MUST stay completely to the right of the solid blend line when entering the track. Violators may be penalized.
 - K. AWARDS:** SCCA US Majors Tour Points will be awarded in accordance with the GCR and these Supplemental Regulations. Trophies for all races will be awarded in accordance with the GCR. Southwest Division Road Racing Championship points will be awarded per 2025 SWRRC Rules and prizes awarded at the end of year.
- III. CAR SAFETY and TECH INSPECTIONS**
- A. DECALS:** Competition vehicles must display the official SCCA Road Racing decal per GCR Section 9.3.29.C (Figure 4). Stickers will be provided free of charge and may be obtained at registration and/or tech. (The official SCCA Summit Racing Equipment Road Racing decal does not serve as the Summit Racing Equipment contingency program decal.)
 - B. TECH:** No smoking or engines running in the Tech Garage. All drivers without a current year helmet sticker must present all driver gear as required by the GCR and vehicle logbook to Tech. If your car requires an annual tech you must also bring the car to Tech.
 - C. SCALES:** Availability of scales and times will be posted at Tech. Scales may be available for participants during race impound, but priority will be given to impounded cars. Scales may be made available at other times at the discretion of the Chief of Tech. Teams are requested to provide crew assistance for weighing their cars.
- IV. QUALIFYING/RACE**
- A. GRID:**

Practice: Starting positions for the first sanctioned, official on-track session will be set based on order of arrival at GRID.

Qualifying: Grid positions for Qualifying 1 will be determined using the fastest lap time in the official practice session. Grid positions for Qualifying 2 will be determined using the fastest lap in either Q1 or Race 1.

Saturday Race: Grid position will be determined using the fastest lap time in the Saturday Qualifying session.

Sunday Race: Grid positions will be determined by the fastest lap time recorded for each car during any of the preceding qualifying session(s) or the fastest lap during the Saturday race.

Note: If qualifying is not run for a group for any reason, the Chief Steward shall determine the method of setting the grid for that group's race.

B. RACE: A driver who is unable to maintain a safe pace during the race, or vehicles leaking/spilling fluids (including fuel), may be black-flagged.

C. Blocking, Starts and Restarts: Drivers are advised to read and comply with the recent SCCA Member Advisory MA 25-01, the provisions of which are incorporated herein regarding enforcement and penalties.

V. IMPOUND

A. MANDATORY DRIVERS MEETING: Either a written Drivers' Meeting from Chief Steward may be emailed to all entrants/drivers in advance of the event, or an Impound All will be given at the end of the first Qualifying session for each group to conduct a driver's meeting. Impound will be in the Tech Area. Look for the signs for proper direction.

B. SPLIT STARTS: Drivers may request a split start after the Saturday qualifying session. The Chief Steward will approve a split start only if the majority of drivers in a session are in favor.

C. IMPOUND: Qualifying: Drivers are not required to report to Impound after their qualifying sessions unless directed to do so by the SOC. **Races:** The top three finishers in each class shall report to Impound immediately following the completion of their race, for both Saturday and Sunday races, for post-race inspection per the pre-approved tech plan. IF IN DOUBT, REPORT TO IMPOUND. **Sunday race:** Impound all following completion of the race for trophy presentation. **The Chief Steward or Tech Steward will be available in impound at the conclusion of each Qualifying and Race session for questions, clarifications or discussion of on-track incidents.**

D. CONTACT: GCR Section 6.11.1.E requires the driver and car involved in significant body contact to stop at the designated incident investigation site for review of the incident by stewards. "Significant body contact" includes but is not limited to: contact resulting in 2 or 4 wheels off course, spins, loss of position, or damage to the suspension or bodywork. Drivers shall satisfy this requirement by reporting to the SOC located on the pit lane at the track exit. Drivers who do not satisfy this requirement are subject to Chief Steward penalties, or may be referred to the Stewards of the Meeting (SOM).

E. DISABLED CAR: If during an on-track incident a car is unable to continue, the driver MUST remain in the car with all safety equipment in place while waiting for EV arrival. The ONLY exception is if the car is on fire.

VI. GENERAL

A. RACE LENGTH: Saturday races will be 20 minutes. **Sunday races will be 35 minutes (or a minimum of 17 laps).** When the LAST LAP INDICATOR is given at Start/Finish, the next flag will be a checkered flag. In the case of a long delay and where the time limit has expired, the Chief Steward may convert to laps to allow a green, white, checker to complete the race.

B. RESULTS: Live timing will be available during the event through [Race Monitor](#) App (the Race Hero App has been sunsetted as of 12/31/2024), and may be available at [SCCA.com](#). Live timing information is neither official nor protestable. Results will only be available at [TX Region Road Racing](#) or by using the QR code included in these Supplemental Regulations.

C. START TIMES: For Qualifying, the session clock starts when cars are released from Grid. For Race sessions the clock starts when the first car crosses the Start/Finish control line after the scheduled pace lap.

D. EVENT SCHEDULE/RUN GROUPS: The schedule or run groups may only be changed at the discretion of the Chief Steward, with concurrence by the Event Chair and approval by the SOM, depending on pre-race entry counts or as needed to accommodate situations during the event.

E. CANCELLATION: If part of an event is canceled for reasons of safety or forces beyond our control as provided by GCR Appendix B.1.2.B., points will be awarded based on race grids.

- F. **CLOTHING:** Safe apparel must be worn in the pits at all times. Crew members on pit lane must display their event credential at all times while on pit lane.
- G. **GRID:** All motorized vehicles (race cars and support vehicles) must enter the grid area by following the designated traffic flow signage as shown in the facility maps included in these Supplemental Regulations. The entry lane into the grid area and the exit lane from the hot pit are **one-way only (as shown in the traffic flow map below)**, and violators may be subject to steward action.
- H. **PIT LANE:** Drivers are to maintain a safe speed on Pit Lane with absolutely no racing. Unless signaling a driver or tending to a car in the hot pits, all persons must remain behind the pit lane wall. Standing or sitting on the pit lane wall is prohibited at all times.
- I. **DRIVER LIABILITY FOR DAMAGE:** Drivers may be held responsible for harm to property, including physical damage to the track or track facilities, and cost of consumables (oil dry) to remediate fluids deposited onto the race track or other paved surfaces (Grid, Tech, paddock, etc.)

- K. **FUEL PROVIDER:** Available at Track SUNOCO 93 Unleaded, 100 Unleaded, 110 Leaded

VII. TRACK RULES

- A. No alcohol consumption by anyone on the grounds in the facility is allowed while track is in use.
- B. Gates close on the track immediately after the last scheduled run session. The track is considered cold, and no person is allowed to enter without express consent from ECR.
- C. Only ECR personnel may open and close the track gates prior to and after an event.
- D. No one under the age of eighteen is permitted to operate a motorized vehicle unless they are registered with the event.
- E. Speed limit in the paddock is 15 mph.
- F. No parking between and around garage buildings.
- G. Do not leave used tires at the facility, take them with you or pay a disposal fee at one of the shops on site.
- H. Dispose of used oil in the waste oil container on site. Ask at the front desk in the Clubhouse for location.
- I. In the case of rain or mud, all vehicles must stay on pavement.
- J. Animals must remain on leash at all times, must be cleaned up after, and are not allowed in the Clubhouse.
- K. Nobody is allowed in the restricted area indicated on the Facility Maps.
- L. No spectators beyond the posted limits on the grounds.
- M. Paddock grounds are managed by ECR staff during operating hours of 7:00 AM – 5:30 PM. Camping is allowed, however operational security on the grounds is not provided. Participants are reminded that ECR is a member-oriented facility and both members and guests have unrestricted access; all participants are personally responsible for securing their possessions at all times during the event. Neither ECR nor Texas Region will be responsible for any loss or damage to personal possessions.
- N. In the event of a vehicle fire, the driver **MUST** make every reasonable effort to move the vehicle off of the racing surface before stopping and exiting the vehicle.
- O. Be safe and have fun!

VIII. OTHER

- A. **LOCATIONS:** **Registration** will be located in the garage at the Clubhouse. **Tech** and **Impound** will be located at the Tech Shed. **Race Control** will be located at the top of the Hill in the Timing & Scoring Building.
- B. The Race Chair, Chief Steward, Stewards of the Meeting, and other race officials will normally be located in the Timing & Scoring Building or at Impound.
- C. Majors Trophies will be available after each race. Impound all following completion of each Sunday race for trophy presentation at ECR Podium. SWRRC Trophies are awarded on an annual championship basis and will be awarded at the end of the season
