LIABILITY WAIVER

THE UNDERSIGNED PARTICIPANTS:

1. HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the sponsors of the above event, the officers and members, along with any other sponsors and all of its holdings, and owners and lessees of premises used to conduct the event and each of them, their officers and employees, the dealers, officers, directors, management, officials and volunteers assisting in the event, the sanctioning organization or any subdivision thereof, grounds operators, grounds owner, officials, promoters, sponsors, advertisers; all for the purpose herein referred to as "releases," from all liability to the undersigned, their personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is participating in the event;
2. **THE UNDERSIGNED AGREES that he or she are entirely responsible for any such damages or injuries, which may include property damage to concrete barriers, guardrails, fences, signage and structures. Any damage caused to the premises is your sole responsibility. Registrants will be billed for any damage to the property.**
3. HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost (including attorney's fees) they may incur due to the presence of the undersigned participating in the event and whether caused by the negligence of the releases or otherwise.
4. THE UNDERSIGNED PARTICIPANTS agree that while participating in this event, the use of alcohol or any substance which affects the ability to operate or control his or her vehicle or may be considered as hazardous to the health and safety of participants and spectators is strictly forbidden.
5. THE UNDERSIGNED AGREES that he or she will not use or operate any vehicle in violation or contravention of any City, County, State or Federal laws, statutes, ordinances or regulation and shall be personally liable for all fines and penalties for traffic law violations, including all vehicle occupants utilizing seat belts at all times and no use of cell phone while driving, even if not prohibited by law.
6. THE UNDERSIGNED HEREBY REPRESENTS EACH OF THE UNDERSIGNED expressly acknowledges that under no circumstances shall AZP Installs of NJ Inc. (together with any of its staff, the "Event Organizer") be held liable for any damage to your car or injuries to you, your passengers and/or spectators which may occur or arise during this event.
7. THE UNDERSIGNED AGREES he or she is solely responsible for the technical inspection of your vehicle. Any technical inspections performed by the Event Organizers are as a courtesy to the participant and does not constitute your vehicle's fitness to be on track.
8. THE UNDERSIGNED AGREES the Helmet inspection is for the sole purpose of determining if it displays the Snell SA/M 2010 or better sticker. No guarantee of fitness for use is associated with this inspection.
9. EACH OF THE UNDERSIGNED expressly acknowledges and agrees that this is not a race or racing school. This is a high speed/performance driving event (HPDE) that is inherently dangerous. Death or serious injury may result if an accident occurs. You agree to hold the Event Organizer harmless from any and all damage or liability which may occur or arise as a result of this event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by law of the State in which it is operated in and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
11. THE UNDERSIGNED HAS FULLY READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agree that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

I understand and accept that in the course of my attendance at and participation in the Event, Film or Photographs may be taken, or illustration may be made of me and/or my personal property (including my Car). I acknowledge and agree that such film/photographs and/or illustrations may be used in any medium by the organizers, promoters, sponsors of this event and all the related entities and agencies for advertising and promotional purposes in any medium, without compensation to me.
