

2021 Winnipeg Sports Car Club COVID-19 Policy and Practices Directive

- This Policy and Practices Directive is applicable to and shall govern all Winnipeg Sports Car Club activities and events until further notice.
- 2. Each Discipline may create supplementary regulations specific to events held at their venue(s) and/or facility(s), provided those regulations are consistent with, and do not contradict, any provision of this Policy and Practices Directive. In the event that any part of the supplementary regulations for any Discipline are inconsistent with the provisions of this Directive, those supplementary regulations must be submitted for review and approval by the Board of Directors.
- 3. All applicable Province of Manitoba Public Health Orders and Regulations will be followed.
- 3. The Winnipeg Sports Car Club is not responsible nor liable for any illness that a person may acquire from attending a Club event.
- 4. Event schedules and registration are subject to change without notice, as necessary and in response to changes to Province of Manitoba Public Health Orders and Regulations.
- 5. Attendees to Club events are required to self-monitor and declare whether they are in compliance with the Province of Manitoba on-line COVID-19 screening checklist available at www.gov.mb.ca/asset_library/en/coronavirus/covid19 screening checklist.pdf
- 6. Attendees who do not meet the screening criteria will not be permitted to attend events and/or will be asked to leave.
- 7. Passengers will not be permitted in any attendee's vehicle unless all occupants are from the same household.
- 8. No in-car instruction will be available or permitted at any event.
- 9. No personal safety equipment rentals will be available. Attendees are required to provide their own helmet and safety equipment.
- 10. There will be no food vendor(s) allowed on-site.
- 11. Registration and payment of fees for all Club events must be made via www.wsccracing.com. Cash payments will not be accepted.
- 12. No spectators will be permitted to attend any WSCC event. Attendees may be accompanied by members of their immediate household only.
- 13. The use of face masks is strongly recommended for all attendees when not driving or seated in their car. Face masks and other Personal Protective Equipment (PPE) will not be provided by the WSCC. Attendees are required to provide their own face masks and any other PPE they may require.
- 14. Radios will be handled by station captains only and must be disinfected and wiped before each exchange.
- 15. We recommend all attendees carry hand sanitizer, and that marshals and corner workers sanitize after handling cones or other equipment (i.e. fire extinguishers, flags, broom, etc.). This is the responsibility of the participant and not the WSCC.
- 16. Only one person is permitted in the timing trailer at a time.
- 17. Access to washroom facilities must be modified to ensure that minimum 2 meter social (physical) distancing protocols are observed at all times.
- 18. Attendees must maintain minimum 2 meter social (physical) distancing protocols at all times when not in their vehicles.
- 19. All attendees are required to either complete the on-line waiver as part of the registration process at www.wsccracing.com, or the annual hard card waiver available at www.wcma.ca.
- 20. This Policy and Practices Directive is subject to review and/or revision by the Board of Directors of the Winnipeg Sports Car Club as circumstances may require.
