Dear Instructor,

Due to COVID-19 Pandemic at this time BMW CCA will not allow in car instructing. Per BMW CCA rules we will be using a "Lead-Follow" instruction method. This may change by the time the event occurs, but we will do some practice sessions on Friday. Please, once registered, pay attention to emails for updates. This is an evolving situation we are working through to make this event happen!

Thank you for your commitment to instruct at our Windy City BMW High Performance Driving Experience (HPDE) at Putnam Park on Saturday and Sunday, August 29 & 30, 2020. Instructor day is August 28th. We will refund your payment Friday and garage rental payment if we have to cancel the event due to Covid-19 restrictions by BMW CCA, the track management or a governmental body.

See the driver letter –attached- for the rest of the information on the experience, times, maps, sample waiver, Medical Form, car insurance option info, etc.

- ➤ Red and yellow groups will have assigned instructors. Green group will be able to choose an instructor, if they wish, from a separate instructor pool.
- Because of COVID-19, we will no longer be doing in-car instruction in red/yellow groups. Instead we will use "Lead – Follow". You will only have either a Red or a Yellow team of drivers to teach. Due to the sudden nature of this change we will have further explanation as it becomes available.
- Please refer to the Lead Follow Webinar at motorsport-safety.org,
 When you go to the website, click on the menu, then resources, then scroll down to Lead Follow webinar. It will explain the Lead Follow technique, it is just over an hour and worth the time.
- There will be no passengers in cars all weekend, no exceptions.
- Bring / wear your own mask. Bring your own pen for signing waivers and Driver Evaluations.

Green Run Group information:

- There will be a Solo run group. Solo run group drivers are highly experienced HPDE
 participants. Eligibility for this run group will be decided by the DEC. The Solo run group will
 run in their own group and also be allowed to run with the instructor group. Instructors can
 drive in the Solo group.
- 2. Solo participants will have the opportunity to select an instructor for a session to lead follow. This gives the experienced HPDE participant the opportunity to continue learning.

Instructor / Driver pairing assignments will be sent via email before the event. Please contact your driver(s) ahead of time to discuss their goals, skill level, car modifications, previous track-driving experience, etc.

Technical Inspection: The form is attached. You must present the signed/certified tech inspection sheet at registration on the day of the event. You must sign the form as participant.

Your car must pass inspection before coming to the event. Bob Rauch Auto Care (847-235-2204) or Ben Rogut (7th Gear) (224-659-3461) can do inspections by appointment only at their shops for a fee. Addresses are on the Motorsportsreg page. There will be NO onsite inspections. There will be NO Chapter pre-tech event. Your vehicle's status is subject to review by the event Tech Steward if questionable conditions are noted. No refunds are given if unsafe vehicles are brought to the event.

The technical inspection is for your safety and the safety of others on the track with you. As this is a BMW CCA national requirement THERE ARE NO EXCEPTIONS TO THIS RULE.

Friday Instructor Day: The instructors' track time will be <u>Friday</u>, August 28th from 9:00 to 5:00. If you cancel more than 24 hours before the Friday Instructor Day (9:00 8/27), you will receive a 90% refund for that day. Otherwise there will be no refund. There will be no riders on Friday.

There will be designated instructor/green group track sessions on Saturday and Sunday. No racing will be allowed. This applies for the whole weekend.

Car: It must be in the car you registered in and must be quiet. If you have a change in cars after registering, notify Randy Everson.

Helmets: Helmets must be SNELL or SFI 2010 or newer. Helmets have to be checked at the track registration if you don't already have a current Windy City BMW inspection sticker (yellow or green).

Parking at Putnam: parking is on the large gravel and grassed areas north and west of the garages. Twenty garages are available for rent on a first-come-first-served basis

At the front gate you must sign the Putnam liability waiver. At Registration you will sign the one for Windy City BMW which signs away your rights and get your wristband. A copy of our waiver is enclosed, please review it.

Saturday and Sunday Morning: The track opens at 7:00 AM. Registration from 7:00 till 7:30 in the garage area. Mandatory Instructor / Driver combined meeting at 8:00 in the pit area near the Tower. Drivers will be introduced to their Instructors and the Lead-Follow system will be explained again to everyone.

You can do a simple paddock check of your driver's car before the first time out on Saturday morning. Please do this same check on Sunday if you have a Sunday-only driver. If you find any safety issues, let an event Chairperson know.

Miscellaneous

If the COVID-19 situation changes you may need a communicator, please be prepared and bring if needed.

All instructors must have a full operator's license that is not suspended or revoked. Equal restraints are needed. If you have a harness, then your passenger needs a harness.

Cars must have mufflers in working order to run.

If you cause property damage at the track, you are responsible for the repair cost.

Driver Evaluation Form: One is enclosed to review, the form may need to change to properly reflect Lead – Follow. Refer to it as you work with your drivers to be sure all points are covered in your instruction. These are the areas of skills we most want to teach. We recommend that after your drivers' last track time you discuss their progress (or lack thereof) during the HPDE. The Committee reviews each evaluation to be able to place the driver in the appropriate run group at their next HPDE. Please let our Chief Instructor know if you instruct a driver who you feel has both the skills and the interest in becoming an instructor. They could be invited to attend a future Instructor Training School to keep our instructor base growing.

Important points:

- * Keep a safe distance from the car in front of you except to pass.
- * If you or your driver has a 360 degree or more spin or four wheels off the track you <u>must</u> come into the pit area to be checked.
- * Racing will NOT be tolerated. ANYONE ENGAGED IN RACING WILL BE EXPELLED, NO EXCEPTIONS, NO REFUNDS.

NO CONVERTIBLES WILL BE ALLOWED ON THE TRACK without a hardtop and SCCA type roll bar/cage

Gasoline & Air: Air and fuel are available at the track (expensive) or 5 miles away at normal pump prices.

Concession Stand: The concession stand will be open each day for lunch or you can go off-site. Your schedule has rest periods to allow time for you to eat. The club will not have water coolers on-site, so bring your own water.


- 1) NO OVERNIGHT CAMPING ALLOWED ON THE PREMISES.
