**Obvious**

**things that move a car to Group-2 include:** Wheel or tire size over +/- 1”, headers, removed catalytic converters, exhaust diameter more than ¼” different than stock, gear changes, ground effects/wings (HS Only), adjustable shocks, etc.

**Obvious things that move a car to Group-3 include:** Non-stock cam, heads, throttle body/carb, intake manifold, Oversize brake rotors, non-stock calipers, non-DOT tires, Non-stock Blower or Turbo, etc. \*\*Coil-overs = Grp 3 \*\*Weight reductions = RP

\*\*Up/backdate between Year Groups (exc C2/C3) = RPAF

*My car complies with all technical inspection requirements of the NCCC Rulebook Chapter 2 or 3 (drags), and I am aware that the event Chairman can re-inspect my car at any time.*
