#### SUPPLEMENTAL REGULATIONS

This event is organized by the Land O' Lakes Region of Sports Car Club of America, Inc. (SCCA) and will be held under the 2019 SCCA Track Event Rules except as amended by these Supplemental Regulations. SCCA Track Events provide an environment for drivers who simply want to increase their enjoyment of driving their vehicle. This Track Event is designed to be a non-competitive opportunity for participants to learn first-hand from experienced driving coaches, and to practice repeatedly, at safe speeds, the basic principles and skills upon which the sport of motor racing is based.

## PERTINENT DATES and FACTS FOR THIS EVENT

- Online registration closes at 11:59 PM on Friday, Oct 19, 2019.
- This Track Event is limited to 45 cars, 15 cars per Group.
- Three Groups: 1.Novice, 2. Intermediate and 3.Advanced.
- In the event of inclement weather, the event may be rescheduled for another date or cancelled.
- Fees will not be charged until the event is underway.
- No walk in registrations will be accepted for Group 1 (Novice) drivers.
- Registration is from 7:30 to 8:30 AM, located at the west end of the parking area, in the DCTC Driving Training Classroom Facility (see map on page 3).
- There will be a mandatory driver's meeting in the track classroom at 8:30 am.

**Multiple Drivers**: One car may have multiple drivers provided all drivers meet the qualifications to drive in Group 3 and all drivers possess an annual SCCA membership. The first driver will register at the regular fee; each additional driver will pay \$25 plus \$20 weekend membership if required. Any team wishing to register multiple drivers must contact the registrar directly.

**WELCOMING ENVIROMENT**: The Land O' Lakes Region aims to provide an inclusive, welcoming environment for all participants. To that end, behaviors such as the following will be considered egregious examples of "Acting in an unsportsmanlike manner", and will be penalized as such:

- 1. Discriminating against, disparaging or verbally abusing a participant because of their gender identity, ethnicity, marital status, sexual orientation, religion, age, or disability;

### **RULES AND REGULATIONS**

Participant Requirements: Drivers must meet one of the following criteria:

Page **1** of **3** revised 8/22/19

- 1. Possess a valid state driver license, or
- 2. Possess a racing license from a recognized motorsports organization, or
- 3. Possess demonstrated evidence of experience relevant to high-performance driving.
- 4. An SCCA Time Trials or competition license is not required.
- Drivers 15 to17 years of age must contact the event registrar to submit a completed SCCA MS-L minor waiver.
- a. All participants, including drivers, volunteers, crew members, and guests must sign the SCCA Release and Waiver of Liability.
- b. Any driver found to have driven on course in any vehicle before having properly completed the waiver signing process or submitting a completed tech inspection sheet will be disqualified from the event with no refund of entry fee and will be removed from the premises.
- c. As part of the learning experience, drivers may be required to work a flag station during one or more sessions when their run group is not on course as directed by the Event Lead or Safety Steward.
- d. Drivers must have a Technical Inspection Sheet completed, and available to present to an SCCA Official


### PADOCK AND PIT LANE RULES:

- a. All minors must be under the direct supervision and accompanied by their parent(s) or acting guardian(s)
- b. No pets are allowed at DCTC without the express written consent of DCTC.
- c. On track hours will be per schedule and/or adjusted as needed for event operations.
- d. No race engines may be run past 15 minutes after the last checkered flag of each day or the time published in the track rules, whichever is later.
- e. All competitors must vacate the premises by 5:30 PM.
- f. All drivers must enter and exit DCTC civilly. No screeching tires or loud engine noises are acceptable. This is a residential neighborhood and we are respectful to our neighbors.
- g. DCTC reserves the right to amend or modify these Supplemental Regulations at any time without notice. Persons who violate these rules will be subject to removal without refund or recourse. The irresponsible use of any vehicle is prohibited. Riding on the outside of any vehicle or trailer is prohibited. These vehicles shall be operated by street licensed drivers. All race support vehicles must have race car number and class prominently displayed.
- h. The use of motorized or non-motorized scooters, skate boards, inline skates or any type of wheeled shoe is forbidden. No radio-controlled devices may be operated from 8:00am 5:00pm.
- i. Firearms, weapons, explosives and illegal drugs are strictly prohibited on the premises.
- j. Drivers may be held responsible for harm to property, including damage to the track and to the environment.
- k. All trash must be placed in the receptacles provided. All tires must be removed from the track grounds.

#### SAFETY:

- a. Safety Technical Inspections will be performed from 7:30 AM to 9:00 AM
- b. While on course, all participants shall wear a safety helmet meeting Snell 2005 or later specifications. See <a href="2019 SCCA Track Event Rules">2019 SCCA Track Event Rules</a> 5.1.1 Loaners helmets may be available. Contact the Registrar or Event Lead if you are in need of a helmet.
- c. For drivers of vehicles without windscreens, including Sports Racers, Formula Cars and Specials, helmets must meet the specifications in 5.1.1 and the following additional criteria:
- d. Helmets must be full face.
- e. A shield, preferably made of impact-resistant materials, shall be used while on course (conventional eyeglasses are not sufficient).
- f. For drivers of any vehicle without a DOT-approved windshield (such as kit-cars) or any other vehicle with less than standard-sized windshield, a shield, goggles or similar face protection made of impact-resistant materials (conventional eyeglasses are not sufficient) shall be worn while competing.
- g. Passing will only be allowed in those sessions designated as passing sessions by the Event Lead. Passing will only be allowed in designated passing zones. All passes can only be made after the car to be overtaken has acknowledged the presence of the overtaking car and signaled on which side the pass is to be made by a hand signal (point-by).
- h. Any driver who spins or leaves the course with all four wheels off course must return immediately to the pits and may not return to the course until authorized by a Driver Coach, Safety Steward or Event Lead.
- i. The only passengers allowed in any vehicle on course during any session are the Driver Coaches approved for this event. No other persons may ride along in any capacity. Violation will result in removal from the event.
- j. Participants may ride as passengers in Driver Coach vehicles.
- k. Passengers other than Driver Coaches may be allowed at the Event Lead's discretion.
