EVENT: **SOVREN SPRING SPRINTS 2025**

**In submitting this entry application, the undersigned Entrant and/or Driver:**

1. Acknowledges that vintage racing is a dangerous activity, having significant risks of bodily injury including death to Entrant/Driver and others, along with risks of property damage. Vintage racing involves risks not present in contemporary racing including, but not limited to, use of race vehicles and support equipment not being constructed to contemporary safety standards, lack of safety equipment and race groupings that may include very different types of vehicles creating visibility problems among the vehicles in the race, along with substantial speed differentials.
2. Assumes full responsibility for the preparation, state of repair and maintenance of his or her vehicle and further agrees that its use during an event (including use in the pits, practice, qualifying or racing) shall at all times be limited only to persons who are registered for the event and accepted by SOVREN and then only in accord with SOVREN's rules and regulations.
3. Agrees that the Entrant/Driver is responsible for the conduct and actions of all their support personnel including friends, family members, crew, or others. The Entrant/Driver and their support personnel shall conduct themselves in a spirit of sportsmanship on and off the track for the duration of the event and shall conform with the rules, regulations, policies, and procedures of SOVREN and shall cooperate fully with SOVREN, its officers, Race Chairman, Competition Committee, Infractions Committee and all race officials and safety personnel. In this regard the Entrant/Driver consents to SOVREN investigating any incidents, on or off track, and taking such action as it deems appropriate. SOVREN will submit reportable events to the Vintage Motorsports Council (VMC) to be shared with other racing organizations, and may also appear in a SOVREN publication, website, or future event.
4. Assumes all risk of property damage or bodily injury/death arising out of or relating to his/her participation in an event. Entrant/Driver on behalf of themselves, their marital communities, personal representatives, heirs, successors, underwriters and assigns ("releasing parties") waive, release, discharge and covenant not to bring any claim against and/or institute any suit, action, claim or legal proceeding against SOVREN, its directors, officers, employees, the Competition Chairman, Competition Committee, the Infractions Committee, and race officials and any support personnel involved with the event any way, as safety personnel or otherwise, which arises out of or relates in any way to his/her participation or failure to participate in an event. The foregoing shall include all risks associated with the response or non-response of medical, fire or other emergency personnel, equipment or facilities. This waiver further extends not only to instances of personal injury/death or property damage, but also to any issues, which may arise with respect to the interpretation or application of such rules, policies and procedures as may be applicable to the event. Releasing parties agree to pay the attorney's fees, costs and expenses of any person released under this paragraph resulting from any claim, action, suit or legal proceeding initiated on behalf of Entrant/Driver in violation of this paragraph.
5. This Agreement constitutes the parties' entire understanding and agreement, supersedes all prior oral and written understandings, agreements, negotiations, statements, representations, warranties, promises and commitments, and may not be changed except in writing signed by all parties. This Agreement binds and inures to the benefit of the parties and their respective marital communities, personal representatives, heirs, successors, underwriters and assigns. If a court of competent jurisdiction holds any provision of this Agreement to be invalid, unenforceable or against public policy, all other provisions will remain in effect and will be construed as if all provisions held to be invalid, unenforceable or against public policy are omitted. In addition, an enforceable provision will be substituted, if possible, which meets the intent of the stricken provision.
6. **PUBLICITY RELEASE:** As a condition of entry acceptance, the entrant and driver agree to permit a Charity to be named and SOVREN to use their name, voice, and/or likeness for news, publicity, and feature use including film, television, print media, and in connection with advertising and purposes of trade.
